

**EFFECTIVE DATE AS OF 1 JULY, 2024**

At Muxics.in (Muxics India Distribution Services LLP) (“Muxics,” “we,” “us,” or “our”), we aim to provide a platform where artists and creators can distribute original music and video content in a lawful, ethical, and responsible manner. This Content Policy outlines the rules for content submission and distribution on our platform. By using the services of Muxics.in, you agree to comply with this Content Policy. Failure to adhere to these guidelines may result in the suspension or termination of your account.

## 1. Original Content Requirement

Muxics.in is a platform for the distribution of original content only. The following rules apply:

- **Original Works Only:** All content uploaded to Muxics.in must be original. You must own or hold 100% rights to the content (music, video, images, artwork, etc.) that you upload. This means you must either be the original creator or have explicit permission from the original creator to distribute the content.
- **Remixes, Mashups, Covers, and Lo-Fi Content:** These types of content are only allowed if you are the sole owner of the content or have obtained all necessary rights and permissions from the original owners to distribute them. Proof of ownership or licensing may be required.
- **Copyright-Free Content:** Any content you upload must not infringe on the copyrights of others. If you upload content that you do not own or have the rights to, it may be removed, and your account may be suspended or terminated.

## 2. Prohibited Content

### 2.1. Political and Anti-Social Content

- **No Political Content:** Muxics.in does not allow the submission of content that is primarily political in nature or is intended to influence political matters.
- **No Anti-Social Content:** Any content that promotes hate speech, violence, discrimination, or any anti-social behavior is strictly prohibited.

## 2.2. Infringing Content

- **No Copyright Infringement:** You must not upload any content that infringes upon the intellectual property rights of third parties. Any content found to violate copyright laws will be removed immediately, and your account may be suspended or terminated. Additionally, you may be held liable for damages.
- **Content ID Violations:** For content distributed to platforms like YouTube, if Muxics.in detects that your content is being misused by attaching it to popular songs, movies, or other content that does not directly involve your submission for YouTube Content ID, Muxics.in reserves the right to remove such content. Any revenue generated from such content will not be paid to the user.

## 2.3. Harmful or Illegal Content

- **Illegal Activities:** You must not upload content that violates any applicable laws or regulations, including but not limited to content that promotes illegal activities, infringes on privacy, or encourages harm to others.
- **Hate Speech and Discrimination:** Any content that promotes hate speech, violence, or discrimination based on race, ethnicity, religion, gender, sexual orientation, or any other factor is not allowed.
- **Explicit or Harmful Content:** Content that is obscene, pornographic, excessively violent, or otherwise inappropriate for a general audience is prohibited.

## 3. Copyright and Licensing Requirements

To distribute content via Muxics, you must meet the following licensing and copyright requirements:

- **Revenue Forfeiture:** Any revenue generated through artificial means will be withheld and not paid to you.

By uploading content to the platform, you represent and warrant that you have the right to do so, and that your content does not violate the rights of any third parties.
